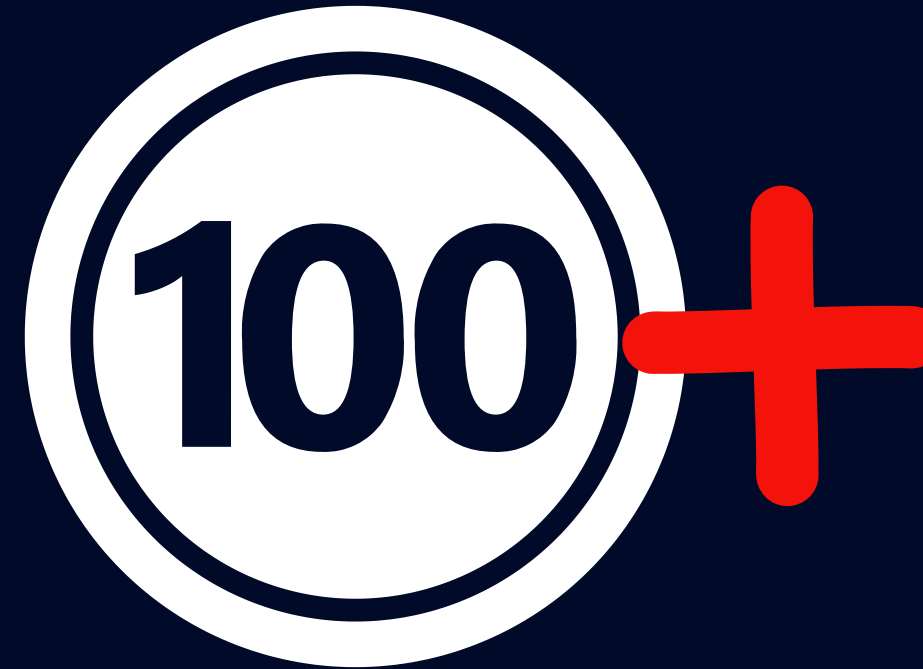

Our thermoplastics coatings are formulated to provide the maximum mechanical properties including corrosion, scratch, chip, and UV resistance. Main Applications:

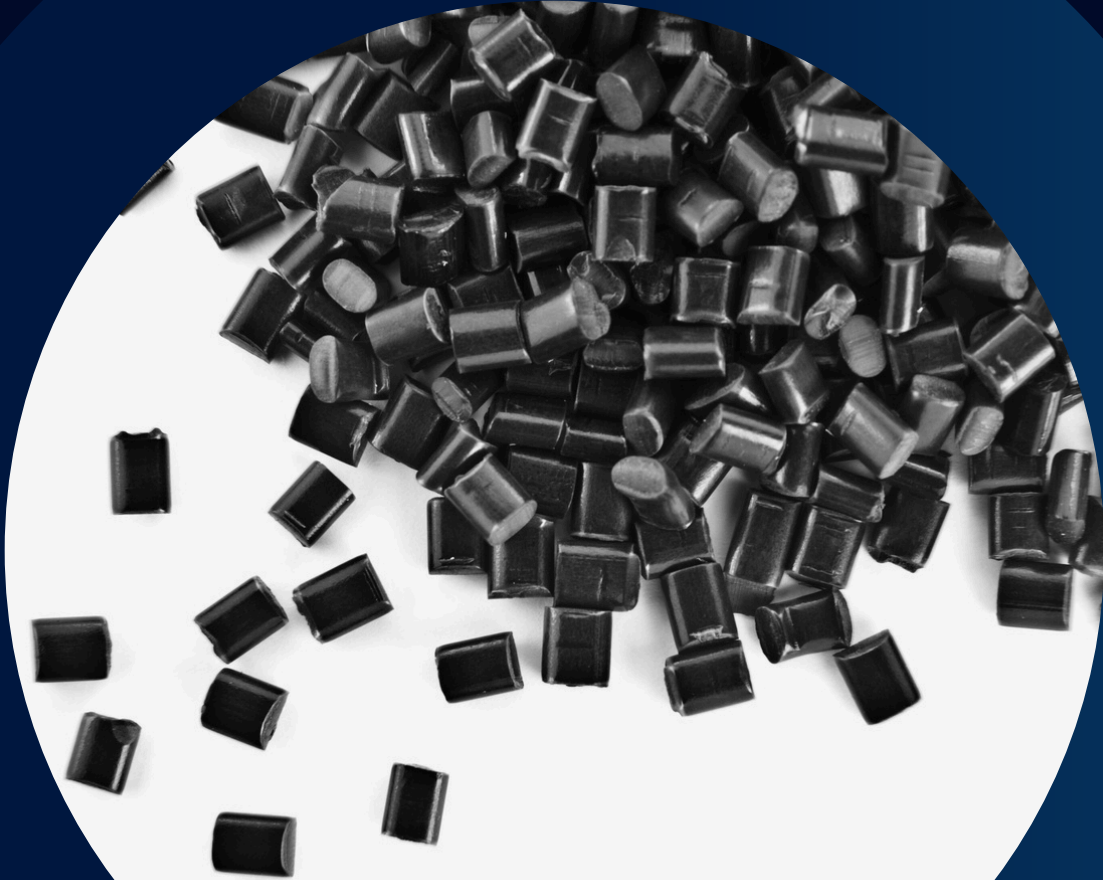
